# <u>Instructions practical procedure of return:</u>

- 1) Print and complete the following RMA FORM indicating carefully the reason for the return and send it by e-mail to: info@demonrace.com
- 2) Keep an eye on your email; within a few days you will receive an email from Demon Race Customer Service accepting or changing the RMA with the assigned practice number; including the cost estimate of the shipping costs of the new item requested in return (to be paid by the customer) and any additional costs to be incurred if you choose an item more expensive than the one to be returned. In case of return with refund there will be no estimate.
- 3) Make the payment estimated by Demon Race to confirm the practice or reply to the email with a request for cancellation if you have changed your mind. In case of return with refund you will not have to make any payment.
- 4) Prepare your product for return in the most accurate way possible to protect it during transport, taking care to attach inside the package a copy of the completed RMA form and proceed with the shipment with a courier of your choice at the following address:

- 6) Upon receipt of the package, the Demon Race Staff will verify that the conditions of the return are met and will proceed with the shipment of the new item requested in return, informing you by email once the shipment has been made; or in case of return with refund will make the refund within 10 days from receipt of the goods, notifying you by e-mail once the procedure is completed.
